Review with Drew Smyth, represented by NCRHHA President Gordon McDonald, regarding the conduct of Mr. Smyth after the qualifying races at Rideau Carleton on 17 April. After discussing the findings of the Panel, Mr. Smyth was adjudged guilty of conduct violations (third violation of the conduct rules within a period of two years) relating to AGCO rules 6.17 (b) (threaten a person), (c) (improper language) and (d) (improper conduct) and was issued a thirty (30) day full suspension with fifteen (15) days stayed. The first fifteen (15) days will be served 29 May to 12 June, inclusive. The remaining fifteen (15) days shall be stayed for a period of two (2) years from the date of reinstatement; any conduct violation during this time will result in the stayed portion of the penalty being reinstated. Additionally, Mr. Smyth ordered to complete an anger management course acceptable to the AGCO prior to reinstatement (Number 2678362).
