**Report on day's events:**

**Office:**

Confirmed the eligibility of Poplar Artie in R9. The Race Office in Charlottetown, PE confirmed that the horse's suspension ended in July, and removed the horse from the Standardbred Canada Judge's List.

After speaking with the Racing Secretary and confirming a race office error, driver Trevor Henry was excused from his drives in R7, R8 and R9. Lorner McClure and Pam Forgie were also excused from one drive each. The change of Tyler Jones to Bruce Richardson in R9 was an early driver change.

**Races:**

R1 – All clear. Winner #2 Blossom Onthebeach requires a negative Coggins test before her next start. Trainer Cameron McQueen was notified.

R2 – Balanced Image Elimination – Ontario Sired 2yo Trotters. INQUIRY – Reviewed multiple breaks in stride starting from the finish line back. #2 Alarming (Bob McClure, 4<sup>th</sup> placed 7<sup>th</sup>) made an extended break (>25 strides) going into the first turn and was placed last as per rule 22.27.02.

R3 – INQUIRY - #1 Stay Lucky (Bob McClure) suffered broken equipment (hobble) before the start and was a pari-mutuel refund of \$1,081. #1 pulled up and did not finish. Reviewed #2 Dirty Lil Piglet in the final turn where the horse gets "steppy" but does not break stride. #6 Marzannk Hanover (5<sup>th</sup>) requires a negative Coggins test before her next start. Trainer Kyle Bossence was notified.

R4 - Balanced Image Elimination – Ontario Sired 2yo Trotters. INQUIRY – Reviewed the break in stride of #5 Macthenight (Scott Young, 3<sup>rd</sup>) before the ½ mile. No violations.

R5 – All clear.

R6 - Balanced Image Elimination – Ontario Sired 2yo Trotters. Starting from the finish line back we reviewed multiple breaks in stride on #1 TH Walker (Bruce Richardson, 7<sup>th</sup>), #2 Lil Sweet (Travis Henry, 6<sup>th</sup>) and #3 Tellers Choice (Tyler Jones, 5<sup>th</sup>). All horses received a fair start, and no placings required.

R7 – All clear. #1 Dusty Lane Morgan (6<sup>th</sup>) requires a negative Coggins test before his next race. Trainer Cameron McQueen was notified. The Balanced Image Final draw was completed in front of the grandstand:
