### OFFICE

- Steven Hudon – \$300 monetary penalty and five-day driving suspension (Sept 25-29) for using more than acceptable wrist action while urging Delcrest Brent in Race 8 at Woodbine Mohawk Park on September 2. AGCO Rules 22.23.03(b), 22.23.05(a)(b), Ruling #2834106.

- Michael Whelan – \$100 monetary penalty – failed to drive the horse Ohare Hanover in Race 5. AGCO Rule 6.02(a), Ruling #2834192.

- Daryl Thiessen – \$100 monetary penalty – failed to drive the horse Armor Seelster in Race 5. AGCO Rule 6.02(a), Ruling #2834256.

### RACES

- Two Prospect Series divisions for 2YO Colt and Gelding Pacers (Races 4 & 7).

Race 1 – All Clear

Race 2 – Inquiry – Reviewed the break by #5 Harborlite Ambrose (Austin Sorrie) in the first turn, finished 4<sup>th</sup> – no violations of the AGCO breaking rule.

Race 3 – Inquiry – Reviewed the break by #3 Mr Commodore (Scott Coulter) before the 3/4s, finished 3<sup>rd</sup> – #3 causes interference to #4 Gravitational (Colin Kelly) and #7 Fall In Line (Travis Henry). Both #4 and #7 finished ahead of #3. The Judges ruled that no other horses were interfered with and as a result there were no violations of the AGCO breaking rule by #3.

Race 4 – All Clear

- #5 D A Playersdelight (J Bradley Harris) was charted with an 'ix' as the horse jumped over debris on the track and was taken inside the pylons.

Race 5 – All Clear

Race 6 – Reviewed pylons on #3 Bring Your Fire (Daryl Thiessen) at the top of the stretch, finished 5<sup>th</sup> – #3 races inside one pylon, no violations of the AGCO pylon rule.

- Two claims entered on #4 Max Patrick were voided as per AGCO Rule 15.11(d) as they weren't submitted within 30 minutes of post time (8:15 PM). The claims were submitted at 7:52 and 7:54 PM. Both parties were offered an explanation on why their claims were voided and educated on how the rule is enforced and applied.

Race 8 – Inquiry – Reviewed the break by #1 Windsun Phoenix (Steve Byron) in the first turn, finished 2<sup>nd</sup> – no violations of the AGCO breaking rule by #1.
