**R1 – INQUIRY**- Reviewed the possible break in stride of #4 Kerwood Kid (D. Wall, 3<sup>rd</sup>) at the finish. The horse got rough, there was no violation of the breaking rule. Also reviewed racing in the stretch between #8 Boots (A. Moore, 5<sup>th</sup>) who was trying to get up inside #6 Motor City Cobra (P. Barr, 4<sup>th</sup>). The front tower camera shows that even driving over a couple of pylons, there was never enough room for #8 to get through.

**R2** – The overcheck came undone on #6 Noneyabizzness (A. Sorrie, 7<sup>th</sup>) after the first turn. The horse was charted finishing with broken equipment (BE).

**R3** - #6 Shadows Lucky Lady finished in 2:08 (C. Germain, 7<sup>th</sup>) and #5 Kielyn finished in 2:05 (P. Mackenzie, 6<sup>th</sup>). Both horses are not within qualifying time for their age group on a ½ mile track.

**R4** – Reviewed pylons after the start on winner #1 Dancelike Ehskipper (J. Ryan) who was inside one pylon and over one pylon. No violation.

**R5 – INQUIRY** - #1 Angry Angel (D. Thiessen, 8<sup>th</sup>) did make a break before the start causing interference to the trailing horse, #8 Czech With Vivian (G. Rooney, 4<sup>th</sup>). #8 was a full pari-mutuel refund of \$4,784.
