- Notification of Certificate of TCO₂ Analysis Number 452432612 from 21 November 2024:
 - Horse: RADLEY HANOVER (1P760) race 6 finished fifth; this horse is entered on the Judges List and is ineligible to race, or be entered to race, for a period of thirty (30) days (27 November to 28 December, inclusive) per AGCO rules 9.07.01(iv) (determine eligibility of horse upon notification of positive result) and 20.01.01(j) (horse placed on Judges list) (Number 2929538).
 - Trainer: Karol Ann Malo Tetreault was notified 27 November with disclosure (by email) to be given 29 November.
 - TCO₂ Result: 37.7 mmol/L (non-EIPH limit 36 mmol/L) (class 3).
 - Ms. Tetreault was advised regarding AGCO rule 26.08 (transfer of horses to the care of another trainer).
