Race 7 – Reviewed pylons on #6 Dusty Lane Morgan (Scott Coulter) in the second quarter, finished 1<sup>st</sup> – races inside one pylon, no violations of the AGCO pylon rule by #6.

- #1 Southern Flight (Travis Henry) was charted with interference due to the break by #4 Always Been Crazy (Carter Gimblett) after the 3/4s, no placings needed.

- #4 finished the race with broken equipment (shoe).

- #8 Very Blue Chip finished distanced and must qualify for Performance.

Race 8 – Recall – Interference by #4 Voracious (Anthony Haughan) on #3 Risky Lightning (Austin Sorrie).

- Reviewed pylons on #6 Walterjustwalter (Carter Gimblett) in the second quarter and around the final turn, finished 2<sup>nd</sup> – races inside one pylon both times, no violations of the AGCO pylon rule by #6.

- #6 finished the race with broken equipment (shoe).

Race 9 – Inquiry – Reviewed pylons on #8 Snow Walker (Paul MacKenzie) around the final turn, finished 4<sup>th</sup> – #8 races inside the pylon leading into the passing lane and was ruled to have gained an unfair advantage on #1 Doctor Grenfell (Steven Hudon) and #7 B Js Choice (Mark Goddard). #8 finished 4<sup>th</sup> placed 6<sup>th</sup>.
