 AND IN THE MATTER OF LAA DEE GAA (7S258) AND BUTTERFLY KISSES
 (0RN93)**

WHEREAS Jimmy Gagnon (“GAGNON”) is licensed by the Alcohol and Gaming Commission of Ontario (“AGCO”) as an Owner, Trainer, and Driver (licence number HP1210696).

AND WHEREAS GAGNON was the trainer of record of horses LAA DEE GAA (7S258) and BUTTERFLY KISSES (0RN93) for the below listed races.

WHEREAS pursuant to SB Ruling 2256184 Owner, Trainer, and Driver Carol Voyer (“VOYER”) (licence number HPR4280) was issued a three-year full suspension – to be served from July 19, 2023 – July 18, 2026.

AND WHEREAS as a result of inspections by the AGCO, it is found that VOYER continued to participate in racing while under suspension (SB Ruling 2256184) by communicating with GAGNON to direct GAGNON regarding the training and racing of horses LAA DEE GAA and BUTTERFLY KISSES.
