OFFICE

- Doug McNair was in to discuss booking off following Race 1 last night and missing his final three drives. No further action is required.
- Kyle Husted picked up disclosure information for TCO2 overage on the horse Doctor Cruise from Feb 8.
- Ruling # 3021041 – Doctor Cruise is ineligible to race or enter in the province in Ontario for 30 days, Feb 12 – March 13/25. AGCO Rules 9.07.01(iv) and 20.01(j).
- Bob McClure excused from four drives.
- Trainer transfer approved on the horse Plaisir from Jimmy Gagnon to Kayla Hendry. Ms. Hendry provided the Judges the required documents for the sale of Plaisir.

RACES

Race 1 – The race fractions for the first half were corrected to :27.4, :58.3.

- Spoke to Jody Jamieson (#7 Powder Play) about the second quarter – Mr. Jamieson is urging the mare coming to the half and she is visibly having steering issues. The horse did not respond to Jamieson's efforts and finished 10th. No violations of AGCO Rule 22.05.01(k).

Race 2 – All Clear

Race 3 – #4 Paradise Moni (LP Roy) finished 6th placed 8th for an extended break.

Race 4 – All Clear

Race 5 – Spoke to LP Roy (#1 Goudawon) about the second quarter, :27, :57.3 – no further action is needed.

- Reviewed the first turn when #8 Western Wish (JR Plante) leaves a hole for #6 Lyons Legend (Jonathan Drury). Mr. Plante stated his strategy was to follow #6, who was the second choice at 2-1, and did pull second-over to that rival in the second quarter. #8 finished 2nd by a nose at 26-1. Judges accepted Mr. Plante's explanation and no violation of AGCO Rule 22.05.01(i).

- Race fractions corrected to :27, :57.3, 1:26.4, 1:55.4.

Race 6 – #5 Rose Colordglasses (LP Roy) finished 8th placed 9th for racing inside the pylons at the 3/4s.

Race 7 – All Clear. Race fractions corrected to :28.3, :58.2, 1:28, 1:57.1.

Race 8 – Inquiry – Reviewed the break by #6 Sunnys Girl (Jame Macdonald) at the start, finished 4th – no violations of the AGCO breaking rule by #6.

- Reviewed racing in the stretch between #4 Th Sandra Dee (Tyler Jones) and #5 Kandy Kiss (Tyler Borth) – #5 bears out towards #4, no placings needed as #4 won the race.

- Race fractions corrected to :29, :59.3, 1:29.4, 1:58.2.

Race 9 – All Clear. Race fractions corrected to :29.3, :59.1, 1:27.2, 1:55.1.

Race 10 – All Clear. Race fractions corrected to :28.4, :59.3, 1:28, 1:57.2.
