Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early Veterinary scratch (sick) of WILDFIRE BLUE CHIP (Philip Reid trainer) from the third race; this horse is entered on the short term (seven days) Veterinarians List.
- Program correction for the tenth race; MAJOR MOTION was entered without a claiming price and is ineligible to be claimed.
- Discussed the ownership situation of ROYAL REGATTA (8N170) with Michel Lavoie and Jason Gilchrist. ROYAL REGATTA is entered on the Judges list and is ineligible to be entered to race, or race, until a resolution is reached between the parties.

Races:

- 1. Clear.
- 2. Start delayed due to an ear plug out on #1 STOMPER TOM (Ryan Guy). The #4 THE MAGIC OF LIFE (Guy Gagnon) qualifies for breaks in consecutive races on a fast track (trainer notified).

Inquiry on #2 SAULSBROOK CAMI (Robert Shepherd), who finished fourth, concerning the breaking rule at the start; #2 broke before the start and was on gait at the start; no violation of any of the breaking rules and no change to the order of finish.

3. As there were only four starters, fifth place money was retained by the Association (AGCO rule 18.02). The #5 JM STELLA (Sylvain Lacaille) suffered broken equipment after the start and finished with broken equipment. Clear.

- 5. The #1 WASTINGNOTIME (Stephane Pouliot) was not in position on the gate when the starter released the field; Starter Jamie Fiolek will address a possible violation of AGCO 22.03(j)(vii) (not in position) with Mr. Pouliot. Clear.
- 6. Start delayed due to broken equipment (head pole) on #7 SILVER MASS (Stephane Pouliot). The driver of #3 FLASHMESOMEGREEN (Pascal Berube) was cautioned regarding his urging in the stretch. Clear.
- 7. The #8 RAISING RUSTY (Melanie Plourde) suffered broken equipment (shoe) after the ½ mile pole and finished with broken equipment. The #3 SOUTHWIND RUSSIAN (Stephane Pouliot) must qualify for consecutive breaks on a fast track (trainer notified). Clear.
- 8. The driver of #3 RONDA DU LAC, Michel Lagace, was cautioned regarding his urging in the stretch. Clear.
- 9. Clear.
- 10. Recall as the #4 SUNSHINE LOVE (Mike Healey) suffered epistaxis prior to the start and was subsequently examined and scratched (sick) by the AGCO Veterinarian; #4 is entered on the Judges and Veterinarians List for 14 days and must qualify (AGCO rules 35.11.00 and 12.06 (trainer notified); parimutuel refund: \$9464.

The driver of #1 SILVERADO, Ryan Guy, will attend a review regarding a possible violation of 22.05.01(i) (leave a hole when it was within the horse's capacity to keep the hole closed). Clear.
