Reminder to all participants that AGCO rule 22.27.02 (extended break resulting in a horse being placed last) has been rescinded. The provisions of AGCO rule 22.27.01 (breaking rules) remain in effect with specific reference to the requirement of a horse to continuously lose ground while off stride.

Races:

R1 – INQUIRY – After the 1/2 #1Speaktothebaran (G. Rooney, 8th) made a break causing interference to the winner Wills Watchin (M. Baillargeon), #8 The Dark Lord (D. Rankin, 2nd), #2 Watch Your Speed (M. MacDonell, 3rd), #4 Summers Shadow (D. Edwards, 5th) and #3 Im Shorty (N. Day, 6th). No placings required, and all horses involved were charted with interference. Judges also reviewed the break before the start by #3 Bree is a Baroness (A. Haughan, 4th). No violation of the breaking rules. #6 Queen Beneva made a break after 3/4 and must qualify for breaks. Trainer Rodney Duford was notified.
