Three elimination heats for The Dream of Glory.

Driver Michael Whelan excused from 1 drive.

Driver Bob McClure excused from 2 drives.

Races:

Race 1: The Dream of Glory Elimination #1-Reviewed break by #3 P C Chattahoochee-(J.Ryan-finished 3rd) after the start. Horse loses ground while briefly off-stride. Also reviewed the break by #4 Tellers Choice (P.Mackenzie) after the start. #4 caused an interference break to #5 Northern Drifter (B.McClure). #5 pulled up after the half and DNF, does not have to qualify on account of the ix. #5 was examined by Commission Vet following the race and put on the short term Vet List-Lame.

Race 2: Reviewed break by #5 Ram (L.McClure)-no violations of AGCO breaking rules.

Race 3: Inquiry-Reviewed racing coming to the ½. As #7 Century Liberty (B.McClure) is advancing on the outside, race winner #3 Bettor Beast (Tra.Henry) moves off the rail from the 3-hole in front of #7. Judges spoke to both drivers and reviewed the race film. The judges determined that #3 had clearance to move off the rail in front of #7. No violations.

Race 4: The Dream of Glory Elimination #2- (no show wagering)-All Clear

Race 5: Recall: #7-Addi Wish (first lifetime start) tried to exit the track through the maintenance chute.

Driver Jeffrey Hunt was issued a \$100 monetary penalty for violation of AGCO rule 22.05.01 (k)-failure to set a pace comparable to class. Splits were 31.2, 104.0, 133.4, 203.1 Ruling #3278627
