- Early Judges scratches (weather) of DALI DALITE (Jacie Woodward triainer) from the fifth race and RJ FLASH (Mark Johnson trainer) from the eighth race.

### Races:

1. Clear.
  2. Driver of #4 SHEZA DANCIN FOOL, Darcy Clancy, was cautioned regarding his urging in the stretch. Clear.
  3. Inquiry concerning possible broken equipment (head pole) on #4 BLAKESAGENT (Doug Brown) before the start; after reviewing the race video it was determined that #4 did not have broken equipment before the start, did receive a fair start and finished with broken equipment. Clear.
- Minute of silence in memory of Murray Samons.

5. Recall due to interference by #2 ALLSTAR SMILES (Ryan Guy) on #1 TOWN DELINQUENT (Nick Boyd) before the start. The #3 LITTLE MARY (Michael Salis) suffered broken equipment (head pole) in the stretch and finished with broken equipment.
