Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Reminder to all participants that AGCO rule 22.27.02 (extended break resulting in a
 horse being placed last) has been <u>rescinded</u>. The provisions of AGCO rule 22.27.01
 (breaking rules) remain in effect with specific reference to the requirement of a horse to
 continuously lose ground while off stride.
- Three Grassroots divisions of Ontario Sires Stakes for three year old filly trotters.

Races:

- Anthony Haughan excused from one drive.
- 1. The #2 CAPTAIN COMMANDO (Tyler Jones) suffered broken equipment (overcheck) after the ½ mile pole and finished with broken equipment. Discussed the #3 LUCKYS BIG BOY not being on the gate with driver Doug Brown who stated he felt the horse was pacing in an unsteady manner. Clear.
- 2. The #6 LOOKMOMICANFLY (John Thomson) suffered broken equipment (overcheck) after the start pole and finished with broken equipment. Clear.
- Late Veterinary scratch (lame) of KENNEDY HANOVER by the AGCO Veterinarian; this
 horse is entered on the short term (seven days) Veterinarians list; refund: \$330. The
 driver of #4 MAKINA RUN FOR IT, Tyler Jones, was cautioned regarding his urging in
 the stretch. Clear.

- 4. Inquiry on #5 HENDERSON SEELSTER (Keith Jones), who finished fourth, concerning possibly leaving the course after the ¾ mile pole; after the ¾ mile pole #2 MUSKIE MAN (Damian Maclellan) broke and while off stride did cause interference to #4 RJ FLASH (Samara Johnson), #5 and #8 FORBIDDEN TREASURE (Doug Brown); as #5 was forced into the pylons by #2 there was no violation of the inner rail rule and no change to the order of finish and no placing required as #2 finished eighth (last); #2 must qualify for breaks in consecutive races on a fast track (trainer notified). Clear.
- 5. The #6 ELLIE (Keith Jones) finished distanced and must qualify for performance (trainer notified). Clear.
- 6. Clear.
- 7. The driver of #7 BELLE BOUBOU, Scott Young, will attend a review regarding a possible violation of AGCO rule 22.19 (failure to keep both feet in the stirrups). Clear.
- 8. Clear.
- 9. The driver of #4 NEVADA DRAGON, John Thomson, will attend a review regarding his urging in the stretch. Clear.
- 10. Reviewed racing between #2 BEACH ROLLER (Ryan Guy) and #5 FORREST PRINCESS (John Thomson) in the stretch concerning possible interference; no violations. Clear.
- 11. Discussed race pace with the driver of #8 DALI DALITE, Ryan Guy, concerning the second quarter (27² 58¹); the explanation of the participant was partially accepted and he was reminded of a driver's obligation when cutting the mile. Clear.
