**Race 1** – Clear

**Race 2** – “**Inquiry**” in the stretch #1 “Im A Papi Hanover” (Cullen 3<sup>rd</sup>) was inside 2 pylons but was forced in by #3 “Twin B Fresh Bet” (McNair 6<sup>th</sup>). No placings required.

#3 was noticeably running in, also finished with broken equipment (shoe).

**Race 3** – Clear – reviewed the stretch #6 “Set Shot” on the lead, McClure does show an attempt to stay to the inside mid stretch and is battling for the win...do not consider a violation of allowing to pass needlessly up the inside.

**Race 4** – Clear - #2 “Carsons Gouda” finished with broken equipment (shoe)

**Race 5** – Clear

**Race 6** – Clear – reviewed the first turn – no pylon violation on #6 “Cold Creek Queso” (Jamieson 3d)

**Race 7** – Clear

**Race 8 – “Inquiry”** at the ¼, #1 “Century Lucifer” (Plante 9th) makes a break in stride on his own, does cause interference to #9 “Grin and Win” (Davis 3rd) and interference to #3 “SOS Sports Bet” (McNair 5th) causing him to go inside pylons. No change.
