The horse was fighting the driving bit and McClure had trouble steering behind the gate. It was the second time Menary raced him with this 'pulling bit' and won't race him with it again.

- Travis Henry – \$300 monetary penalty and five-day driving suspension (July 21-25) – failed to keep both feet in the stirrups and allowed his foot to make contact with the horse Nova Blu in Race 3 on July 1/25. AGCO Rule 22.19, Ruling #3241406.
