Races:

Race 1 – Clear - #3 "Lily Rein" finished with broken equipment (2-minute-hitch).

Race 2 - "Inquiry" before the start #3 "Brians Halo" (Jamieson) broke the 2-minute-hitch, refunded \$23,722. https://youtu.be/H9-28soleW4

Race 3 - Clear - reviewed stretch #2 "Industrialists" (Davis) finished 5th and placed 6th for failure to continuously lose ground while off-stride.

#3 "Goal Digger" (Borth) made a break in stride in the stretch and broke his driving bit. The horse did pull up down the backstretch and Driver Borth was unseated. The horse ran loose and eventually caught behind the paddock.

Borth was examined by the Mohawk EMS paramedics and cleared to continue driving.
