• Early Judges scratches (weather) of SHADOW DAVE (Mike Healey trainer) from the first race and ROCKINMYDREAM from the sixth race and SASKABUSH STEVE from the ninth race (Alain Martin trainer).

Races:

- Pascal Berube, Melanie Plourde and Robert Shepherd each excused from one drive.
- Inquiry on #3 HELLAS ROCKET (Sebastien Turenne) concerning possible broken equipment before the start; after reviewing the race video and speaking with Starter Jamie Fiolek it was determined that #3 suffered broken equipment (shoe) after the start and did receive a fair start.

Discussed race pace (28³ 59¹) with the driver of #5 STAR DOG, Ryan Guy, concerning the second quarter; considering the explanation of the participant, that #5 was gapped off the trailing horses and the class no penalty was assessed although Mr. Guy was cautioned regarding 22.05.01(k) (pace comparable to class). Inquired of the driver of #1 POOTIE CAT, Luc Loyer, regarding not having both feet in the stirrups in the stretch; the explanation of the participant was accepted. Clear.

The #5 PURELY WICKED (Clarke Steacy) broke after the start and was examined by the AGCO Veterinarian post race and pronounced fit to race. Clear.
