### Races:

**Race #1** – Clear.

**Race #2** – #8 BRINDLE finished with broken equipment (shoe). Clear.

**Race #3** – Inquiry – Reviewed the break before the ½ by #7 NIGHT WASH (N. Boyd, 4<sup>th</sup>). No violation of the breaking rules by #7 and no change to the order of finish.

#1 CABO SAN LUCAS finished with broken equipment (race bandage).

**Race #4** – Clear.

**Race #5** – Reviewed the break by #7 FLY BULLDOG FLY (N. Boyd, 9<sup>th</sup>) before the ¼ pole causing interference to the #8 CAR WASH BLUES (A. Haughan, 5<sup>th</sup>). #8 was charted with interference. No placings required.

**Race #8** – Reviewed the break before the  $\frac{1}{4}$  pole by #3 TAHOE SEELSTER (D. Thiessen). #3 finished seventh and was placed eighth for causing interference to #1 ODDS ON BULLFROG (D. Brown, 2<sup>nd</sup>), #2 TRAMONTO (J. Ryan, 6<sup>th</sup>), #5 NEVERLEAVEHARLAN (A. Haughan, finished 8<sup>th</sup> was placed 7<sup>th</sup>) and #6 LOU WHO (S. Hudon, 4<sup>th</sup>).

**Race #9** – Inquiry - Reviewed the break in the stretch by #6 FORREST LEAH (J. Thomson, 4<sup>th</sup>). No violation of the breaking rule by #6 and no change to the order of finish.

**Race #10** – Reviewed the break after the  $\frac{3}{4}$  pole by #3 DIME BETTOR (J. Drury, 8<sup>th</sup>); #3 was charted with an equipment break and finished with broken equipment (hobble). As a result of the break by #3 the #7 LYONS GUSTAVOFRING (D. Brown, 6<sup>th</sup>) was charted with interference.
