Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Review held with driver John Thompson concerning his urging of NEVADA DRAGON in the ninth race on 26 July; after reviewing the race video and discussing the urging requirements concerning AGCO rule 22.23.03(b) (more than acceptable wrist action) the Panel reserved their decision.
- Early Veterinary scratches of FEARGIVER (sick) from the first race (Jason Woodward trainer), ROCK N ZEUS (lame) from the fifth race (Macy Cassell trainer) and READY FOR FUN (sick) from the eighth race (Amanda Riley trainer); these horses are entered on the short term (seven days) Veterinarians List.
- Early Judges scratch (transportation) of BET ON BRETT (Randy Ertel trainer) from the fifth race.

Races:

- Discussed urging when not in contention with the driver of #4 HAYICANFLY, Doug Hie. Clear.
- 2. Clear.
- 3. The driver of #1 VICIOUS ALOICIOUS, Nick Boyd, will attend a review regarding his urging in the stretch. Clear.
- 4. Clear.
- 5. Inquiry concerning possible interference by #4 BURLESQUE SEELSTER (Nick Boyd), who finished fifth, on #9 CODYS MOMENT (Doug Hie), who finished sixth; after

reviewing the race video and speaking with both drivers (Mr. Hie stated #4 had hooked his wheel and Mr. Boyd stated that he had driven to the inside and hooked the wheel of #9 who he stated was slowing) it was determined that in the deep stretch #4 did drive up and hook the inside wheel of #9, causing interference to #9; #4 finished fifth placed sixth for (AGCO rule 22.09). Clear.

- 6. Discussed allowing the horse to respond to urging and allowing an appropriate response time with the driver of #2 DA CINNAMON CRUNCH, Drew Smyth. Clear.
- 7. Discussed a possible violation of AGCO rule 22.05.01(e) (allow a horse to pass on the inside) with the driver of #3 PL QUICKSAND, Nick Boyd, regarding the #2 GYPSY JOE (Doug Hie) going up the rail and finishing ahead of #3; the explanation of Mr. Boyd was accepted and no regulatory action is required. Clear.
