## Report on day's events:

## Office:

- Review held with driver Nick Boyd concerning his urging while driving VICIOUS ALOICIOUS in the third race on 2 August; after reviewing the race video and discussing the pertinent rules (AGCO rules 22.23.03 (b) (more than acceptable wrist action) and 22.23.03 (c) (whip outside confines of bike)), an official warning was entered on the licence of the participant.
- Early Judges scratch (transportation) of THE CHEEKY BUGGER (Boyd Wilson trainer) from the first race.
- Discussed urging requirements and obligations with driver John Thomson.

## Races:

- John Thomson excused from two drives.
- John Macmillan excused from one drive.
- 1. Reviewed the performance of #7 CLAYMORE (Ryan Guy), who finished second, after the \(^3\)4 mile pole where this horse slowed considerably and then came back on: Mr. Guv stated that the horse was on one line after the ½ mile pole and was bearing in substantially after the \(^3\)4 mile pole. Clear.
- 2. Clear.
- 3. Inquiry and driver's objection concerning possible interference by #7 BIG BULLY (Darcy Clancy), who finished third, on #2 ALWAYS ADELE (Isaac Waxman), who finished fourth, before the 3/4 mile pole; after reviewing the race video and speaking with the

drivers concerned (Mr. Waxman stated #2 had beared in on his horse; Mr. Clancy stated there was sufficient room and he had not interfered with #2) the objection was disallowed; no change to the order of finish. Clear.

- 4. Reviewed the performance of #1 WHIZZER WALLEE (Mark Goddard) before the ¼ mile pole; the #1 had inside position on #2 TORSTON (Ryan Guy), allowed #2 to take the lead and then went to the middle of the track; Mr. Goddard stated that his horse beared out attempting to exit the track through the maintenance gate; no violations. Clear.
- 5. Inquiry and driver's objection concerning possible interference by #3 SHANES DREAM (Ed Peconi jr.), who finished first, to #7 FORREST LEAH (John Thomson), who finished eighth; after reviewing the race video and speaking with both drivers (Mr. Thomson stated #3 had beared out going to the ½ mile pole contacting the front leg of his horse, causing his horse to break; Mr. Peconi stated he had attempted to go back in but had contacted #7) the objection was upheld; #3 finished first placed eighth (AGCO rule 22.09).

Mr. Peconi was adjudged guilty of violating AGCO rule 22.05.01(a) (bear out into another horse) and was assessed a three day driving suspension (14-16 August, inclusive) (Number 3300646).

The #1 MOVING OVER (Murray Brethour) suffered broken equipment (buxton and quick hitch) at the ½ mile pole causing this horse to break (charted with an equipment break) and finished with broken equipment. Clear.
