RACES

- One division (Leg 2) of the Dream Maker (Race 6).

Race 1 – Reviewed pylons on #3 Firefliesnthunder (Doug McNair) in the stretch, finished 3rd – horse hits three pylons but does not race inside any pylons; no violations of the AGCO pylon rule.

Race 2 – Inquiry X 2

- Inquiry #1 Reviewed pylons on #5 Calypso Creek (JR Plante) around the final turn, finished 3rd – the pan video shows #5 races inside two consecutive pylons and hits multiple pylons. The Judges ruled #5 was forced inside the pylons by #4 Mandestiny (Jody Jamieson). #5 was charted with interference and no placings were needed.

- Inquiry #2 – Reviewed the break by #7 Wholetthedogsout (Bob McClure) going to the half. The low pan video shows #7 has a shoe come loose and it gets stuck in the hopple, which causes the horse to go off stride. McClure took the horse into the safety lane and #5 Calypso Creek (JR Plante) followed into the safety lane. #5 re-entered the racing surface when he had clearance. #1 Major Money (James Macdonald), #2 Spare (Travis Henry), #3 Full Of Colors (LP Roy), #4 Mandestiny (Jody Jamieson), and #6 Tahoe Seelster (Trevor Henry) also suffered interference. #7 finished 7th placed 8th for interference while on a break and was charted with an equipment break.
