### Office:

- Notice of Review delivered to driver Sylvain Lacaille to attend the Judges Office at Rideau Carleton on 13 August at 1630 hours regarding possible violation of AGCO rules 22.23.03(b) (more than acceptable wrist action) in the first race and 22.23.04(c) (lines above head) in the third race on 16 July.
- Several participants were reminded about their obligation regarding outstanding monetary penalties.

### Races:

- Clarke Steacy excused from one drive.
1. Clear.
  2. Clear.
  3. Recall due to an equipment malfunction (line caught on the jawbreaker) on #2 VISTA VERDE (Pascal Berube). The #3 NEXT OF KIN (Marco Lanoie) must qualify for breaks in consecutive races on a fast track (trainer notified), suffered broken equipment (buxton) after the break and finished with broken equipment. Clear.
  4. Clear.
  5. Report from the Chief Test Inspector that the #1 DONATOVER, who had been selected to provide an official sample, arrived late to the retention area and unharnessed; upon investigation the #2 NEVER MIND was announced as the spot test in error by the Paddock Judge; no penalty to trainer John Macmillan regarding violation of AGCO rule

- 9.11 (any horse for which an official sample has been ordered shall be taken without delay to the retention area) considering the circumstances. Clear.
6. Late Veterinary scratch (lame) of ROCKINMYDREAM by the AGCO Veterinarian; this horse is entered on the short term (seven days) Veterinarians list; refund: \$1845. Clear.

Reviewed the performance of #6 BLUE ELVIS (Ryan Guy) concerning possible broken equipment before the start; #6 broke before the ¼ mile pole then suffered broken equipment (buxton) and finished with broken equipment; while off stride #6 did cause interference to #7 DA PLAYERSDELIGHT (William Roy); no placing necessary as #6 finished seventh (last). Clear.
  9. Recall due to broken equipment (head pole) on #5 TYRONE BOW TIE (Ryan Guy). Clear.
