- In Race 7, #6 Marvin Hagler had a mishap coming off the trailer and was scratched by Dr. Stovman. The horse was placed on the long-term Vet's List (lame).

RACES

Race 1 – Reviewed pylons on #6 Bandura (Austin Sorrie) in the first turn, finished 3rd – races inside one pylon, no violations of the AGCO pylon rule.

Race 2 – Inquiry – Reviewed racing past the half between #1 Bonito Boy (Ed Hensley) and #6 The Bear A Cuda (Austin Sorrie). The pan video shows #6 is advancing first-over when #1 pulls out of the three-hole and forces #6 to change course and go three-wide on the turn. The Panel ruled #1 was late coming out of the hole and caused interference to #6, #1 finished 3rd placed 5th for interference.

Race 3 – Inquiry – Reviewed the breaks by #1 Talbot Patriot (Rodney Hughes), #2 Arbela Hanover (Samuel Fillion) and #7 Annabella Bianco (Brett Macdonald) in the first turn. #1 makes the initial break, which causes #2 to go off stride and then #7 made a break. Both #2 and #7 were charted with interference breaks, no placings were needed.
