Driver Garry MacDonald was excused from one drive this afternoon.

## **Races**

Race 1 – Reviewed pylons on #3 Toureg Seelster (D. Thiessen, 2<sup>nd</sup>) in the stretch turn. #3 was inside one pylon – no violations. Also reviewed pylons on #1 Old Buck (D. McNair, 1<sup>st</sup>) going to the <sup>3</sup>⁄<sub>4</sub> pole. #1 was inside one pylon – no violations.

Race 2 – INQ: #2 Duvutos Shadow (B. Richardson, 4P5) made a break in the first turn and did cause interference to #3 Bettor Story (S. Fillion, 5P4). #2 finished 4<sup>th</sup> and was placed 5<sup>th</sup> behind #3 for causing interference while on a break.

Race 3 – Clear. #2 Brookdale Charlotte finished distanced and must qualify for performance.

Race 4 – Reviewed racing in the first turn. #3 Cleopanther (Tra. Henry, 2<sup>nd</sup>) takes the turn wide. #4 Tour Finale (M. Horner, 3<sup>rd</sup>) is on the outside of #3 but has already started to move out around the turn to get by #5 Jalapeno Cheddar. No violations.

Race 5 – Clear. #6 Batten Down made a break after the ½ pole and must qualify for breaks.

Race 6 - Clear.

Race 7 – Clear.

#3 Lyons Goodrow (A. Sorrie, 2<sup>nd</sup>), trained by Anthony Beaton, did fail to go directly to the test barn following Race 7. Judges confirmed with the starter and the paddock judge that the test horses were announced. #3 arrived at the test barn late and fully striped. A \$200 monetary penalty is hereby assessed for violation of AGCO Rule 9.11. Ruling #3358616

Race 8 – Reviewed breaks on #3 Mattys Halo (A. Haughan,  $6^{th}$ ) and #6 Small Town Road (D. Thiessen,  $5^{th}$ ) going to the ½ pole. No violations. #6 must qualify for breaks.

#4 Muscle Charm must qualify for time (207 3/4).

Race 9 – Clear.

Race 10 – Inquiry: #2 Dandy's Showtime (N. Gugliemi, DNF) made a break and fell as the horses were released before the start. Warning lights were activated. Driver Gugliemi was able to get the horse to it's feet and lead the horse off the racetrack surface. The rest of the race continued without incident.

#2 was made a complete pari-mutuel refund due to failure to reach the starting point for the race. Refund \$763.

#2 was examined by the Official Vet and put on the short-term Vet List Lame. The driver Nello Gugliemi was examined by EMS and cleared. #2 must also qualify for performance.
