Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Review held with driver Ryan Guy concerning a possible violation while driving SPORTS ACTIVATOR in the first race on 13 July; after reviewing the race video and discussing the race events Mr. Guy was adjudged guilty of violating AGCO Rule 6.17(d) (improper conduct) and assessed a monetary penalty of \$200 (Number 3365160).
- Review held with driver Ryan Guy concerning a possible violation of AGCO 22.23.03(b) (more than acceptable wrist action) while driving BAYFIELD BEACH in the fourth race on 20 August; after reviewing the race video and discussing the urging requirements an official warning was entered on the licence of the participant.
- Review held with driver Ryan Guy concerning causing interference to SOUFFLE DE VIE (Jason Gilchrist) before the ½ mile pole while driving SPORTS JACKET in the tenth race on 20 August; after reviewing the race video and discussing the race events the explanation of the participant was partially accepted and no further action is required.
- Review held with driver Melanie Plourde concerning a possible violation of AGCO rule 22.05.01(h) (contact another sulky) while driving MAE LOSE CONTROL in the eighth race on 14 September; after reviewing the race video and discussing the race events with Ms. Plourde the Panel was unable to determine interference had been caused to SMILINGBILLY THE KID (William Roy) and no penalty is issued.
- Review with driver Mike Healey concerning a possible violation of AGCO rule 22.05.01(k) (pace comparable to class) while driving ROCKINMYDREAM in the second race on 14 September: after reviewing the race video and discussing the race events and official warning was entered on the licence of the participant.

Inquiry and driver's objection concerning possible interference by the race winner HAKA TIMATANGA (Ryan Guy) on #4 LITTLE KASSARA (Clarke Steacy), who finished third; after reviewing the race video and speaking with both drivers (Mr. Steacy stated he did not have full access to he passing lane; Mr. Guy stated he had maintained a straight course it was determined that there was no violation of AGCO rule 22.05.02.2 (passing lane) by #6; objection disallowed and no change to the order of finish.

The #3 BUILT TO THRILL (Pascal Berube) broke before the ¼ mile pole, pulled up, did not finish and was vanned off the track; this horse was examined post race by the AGCO veterinarian and placed on the long term Veterinarians list (lame) and must qualify (trainer notified). Clear.
