

#### Office:

- Early Judges scratches of GOT NO MORE (other, Daniel Dulude trainer) from the sixth race, TOPVILLE ON A VIRG (transportation, Schae Kelly trainer) from the seventh race and ROB (other, Darcy Clancy trainer) from the eighth race.
- Early Veterinary scratch (sick) of MONTYSGONEMARBLE (John Macmillan trainer) from the tenth race; this horse is entered on the short term (seven days) Veterinarians list.

## Races:

- Claude Larose and Antonio Vecchio each excused from one drive.
- 1. The #6 WINDSUN HUDSON (Ryan Guy) suffered broken equipment (hopple) before the \(^3\)4 mile pole causing this horse to break after the \(^3\)4 mile pole, pulled up and did not finish. Clear.

Inquiry concerning possible interference by #3 STONEBRIDGE HERMES (Ryan Guy), who finished fourth, on #4 LOGAN BEHOLD (Robert Shepherd), who finished sixth; after reviewing the race video and speaking with both drivers (Mr. Shepherd stated he was forced to go three wide; Mr. Guy stated there was sufficient room to come out) it was determined that both horses had moved at the same time and there were no violations; no change to the order of finish.
