Race 2 – Clear. #3 Abbys Medal made a break before the ½ and must qualify for breaks.

Race 3 – Recall: #3 Emilleah on #2 Sweet Sister. Also reviewed start after the race. #3 (S. Fillion, 4<sup>th</sup>) gives #2 (P. Mackenzie, 2<sup>nd</sup>) room to get on the gate. Spoke to driver Mackenzie who said that his horse was green and a bit amped up after the recall, so he was just being cautious with her coming to the start.

Race 4 – Clear. #1 Kalico Seelster finished with broken equipment (headpole).

Race 5 – Reviewed racing going to the ¼ pole. #9 Little Mary (M. Salis, 4<sup>th</sup>) gets a bit rough but does not break stride.

Race 6 – Inquiry: #3 Mikes Tony (S. Fillion, 4<sup>th</sup>) made a couple breaks going to the quarter pole. No violations.
