- #5 did go inside 3 consecutive pylons at the top of the stretch when not forced to do so
- #6 got rough and went inside the safety lane after the ½ pole. #6 did fail to lose continuous ground while inside the safety lane and finished 5th.
- #5 finished 6th and was placed 7th for being inside three consecutive pylons.
- #6 finished 5th and was placed 7th for leaving the course and failing to lose continuous ground inside the pylons.
- #5 was placed back to 6th as a result of the placing of #5.

#6 also broke stride after the start and after the half and must qualify for breaks. #6 was put on the short-term vet list lame by the official veterinarian.
