## **OFFICE**

- Ruling 3241406 Driver Travis Henry has withdrawn his appeal from July 1/25 and will serve his suspension days on October 14 18.
- In Race 1, #2 Cold Creek Espero was programmed with the incorrect ownership. The horse is still under the ownership of Cold Creek Standardbred. Judges spoke to Daniel Walker and Scott Enman about the error and confirmed the correct purse money has been paid out.
- Judges spoke to Security about the correct time being displayed on the paddock clock where horses are checked in to ensure there are no conflicting times going forward.
- A reminder to all Racing participants that chin straps and safety vests **MUST** be worn when on the racing surface. Failure to do so will result in a monetary penalty. Paddock Judge Jody McGilveary made numerous announcements throughout the evening to ensure all participants are complying with this requirement.
