Report on day's events:

OFFICE

- A reminder to all Racing participants that chin straps and safety vests **MUST** be worn when on the racing surface. Failure to do so will result in a monetary penalty. Paddock Judge Jody McGilveary made numerous announcements throughout the evening to ensure all participants are complying with this requirement.
- Race Official Bryan Richardson training tonight.
- Daryl Thiessen, Race 12 on Saturday \$100 monetary penalty, AGCO Rule 22.19, Ruling #3404858
- Tyler Jones was in to discuss his actions at the finish with Bingo Night in Race 6 on Friday. Mr. Jones is aware of the expectations when both lines are placed in one hand. No further action is needed.
- Spoke to Jonathan Drury about his urging in Race 13 on Saturday night, no further action is needed.

RACES

- There was an ambulance delay for the start of Race 1. The field went to post at 7:35PM. Judges will be following up with Management regarding the issue.

Race 1 – Inquiry – Reviewed the break by #6 National Tier (Anthony Haughan) in the stretch and finish, finished 4th. #6 was double lapped by #3 Lyons Dukey (Jody Jamieson) and #5 Im A Papi Hanover (Travis Cullen) at the wire. The Judges ruled that #6 caused interference to #2 Zebs Krafty (Tyler Jones) before the finish. #6 finished 2nd placed 4th for a double lapped-on break and then placed 5th for causing interference.

Race 2 – #4 Alimony Mike finished the race with broken equipment (shoe). Race All Clear.

Race 3 – Recall – #4 Tellers Choice (LP Roy) broke and started ahead of the gate. The horse ran off and didn't get pulled up until the quarter pole. The horse was a Judges scratch.

Inquiry – Reviewed the break by #6 Shesamanalishi (Bob McClure) before the start – horse was not inside the Fair Start Pole. No Inquiry video as the horse was too far back.

Race 5 – Inquiry – Reviewed the break by #6 D A Super Glo (Billy Davis) in the second quarter, finished 3rd. The Judges ruled #6 caused interference to #4 Wicked Express (Doug McNair) and #5 Boyd Bay (Trevor Henry). #6 finished 3rd placed 6th for interference while on a break.
