Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office: A review was held with Bob McClure regarding the post parade of Race 9 on Saturday October 11th, 2025. Decision reserved.

Reviews were held with drivers Louis Philippe Roy and Doug McNair stemming from an incident report after Race 6 on September 30th, 2025. Decision reserved.

Horseperson Barry Bird was assessed a full suspension of three days (October 20th, 2025, to October 22^{nd,} 2025, inclusive), a monetary penalty of five hundred dollars and completion of the AGCO Equine Medication Use and Awareness program. Barry Bird renounces his right to appeal by accepting the above penalty. The penalty is a result of a Class IV positive analysis on the horse Apache Creek from Race 4 on July 6th, 2025, at Georgian Downs.

AGCO Rules 9.09(b), 26.02.01, 26.02.02, 26.02.03. Ruling #3410266.

Terry Fritz was excused from one drive. (Race 5)

Race 1: Reviewed the break of #10 Stonebridge Queen after the half mile mark.

Race 2: Clear

Race 4: #7 Beauty Is Blind must qualify for performance. The horse after being parked for three quarters, went to the outside and allowed all the horses behind her to pass on her inside. Driver J.R.Plante confirmed that the horse was steppy and did not like how she felt.

Race 5: #1 Stonebridge Impish was charted with an equipment break (hopple) before the half mile mark, pulled up and did not finish.

#8 Fire Control must qualify for breaks.

Race 8: #7 Ima Dinosaur was scratched lame after warming up by the Official Veterinarian and placed on the Short-Term Vet list.

Reviewed the break of #5 My Way in deep stretch, the horse rolled off on his own.
