## Report on day's events:

**Office:** Breeders Crown Finals for 3-year olds & Aged - Trot and Pace.

From Race 6, the horse Gimpanzee Dancer was programmed in error to race without Lasix. The horse was eligible to race on Lasix by the fact that the horse was placed on the EIPH program from the June 12<sup>th</sup>, 2025 start at Scioto Downs.

Also from Race 6, the horse Monserrate was programmed in error to race without trotting hopples. The horse raced with hopples this evening and raced his entire 2025 campaign with trotting hopples, not denoted in the program.

## Races:

Race 1: #2 Vandiemen Bluechip (D.McNair) finished 5<sup>th</sup> and was placed 7<sup>th</sup> for going inside two consecutive pylons in the stretch and was lapped on at the finish by #9 Its Major Major A, 7<sup>th</sup> placed 6<sup>th</sup>, and #10 Arbitrage Hanover, 6<sup>th</sup> placed 5<sup>th</sup>.

Race 2: Reviewed the break of #5 Date Night Hanover at the head of the stretch.

Race 3: #1 Twin B Joe Fresh was scratched after warming up by the Official Veterinarian and placed on the Short-Term Vet's List (lame).

Race 4: Reviewed the break of #10 Miss Belmar in the stretch.

Race 5: #4 The Last Martini (D.McNair) and #5 Miki And Minnie (D.Dunn) finished first in a dead heat.

#3 Rose was charted with an interference break before the quarter after being interfered by #7 Faze. No placings needed as #3 Rose finished 9<sup>th</sup> and #7 Faze finished 10<sup>th</sup>.

Race 6: Reviewed the break of #5 Monserrate after the start.

Race 7: Clear.

Race 8: #1 Madden Oaks (L.P.Roy) and #10 Fusion (D.Dunn) were charted with interference when they hooked wheels before the three-quarter pole. #1 Madden Oaks finished 9th placed 10th and #10 Fusion finished 10th placed 9th.
