**Office:** Horseperson Howard Taylor was immediately fully suspended regarding AGCO Rule 3.10. From the Delaware Harness Racing Commission, Ruling HAR-79-25, Howard Taylor was denied a license to participate. AGCO Reciprocal Ruling #3390888.

The judges received an Incident Report from WEG Security (Inc-30119), from September 30<sup>th</sup>, 2025, regarding unlicensed participant Mike Pennington. The judges will follow up with employer Blake Macintosh.

The judges received a second Incident Report from WEG Security (Inc- 30120) from September 30<sup>th</sup>, 2025, regarding drivers Doug McNair and Louis-Philippe Roy following Race 6. The judges will follow up with both drivers.
