- All participants are reminded that chin straps are required to be properly attached and safety vests worn at all times while on the racing surface when training, warming up or racing per AGCO rules 6.29.01 and 6.39; violation of either of these rules will result in a monetary penalty.
- Early Judges scratches (transportation) of BUSINESSONTHEBEACH (Catherine Lafrance trainer) from the sixth race and MOONLIGHTBOY (Stephane Gagnon trainer) from the eighth race.
- Early Veterinary scratches (sick) of WOODMERE GAELIC (Steve Belisle trainer) from the third race and VELUCANDOITCUPCAKE (John Macmillan trainer) from the sixth race.
- Review held with driver Guy Gagnon concerning a possible violation of AGCO rule 22.19 (feet out of stirrups) while driving CAPTAINOFROCKNROLL in the tenth race on 5 October; after reviewing the race video and discussing the events the participant was adjudged guilty of violating this rule (second violation within a period of one year) and assessed a monetary penalty of \$300 and a driving suspension of five (5) days (20-24 October, inclusive) (Number 3408442).
