Outrider Marie Brooking did an excellent job getting the operator to move outside, avoiding a possible accident. #4 Pullaway Ace (4th) driven by Kelly Hoerdts was given an interference as the horse started to slow up after seeing the tractor by the outside fence. #9 Gotchabythetoga (8th) finished with BE (flat tire).
