## Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

**Office:** Trainer Anita Ouellette was issued \$100 monetary penalty for causing a stable error scratch with the horse Maple Shadow from Race 6. AGCO Rule 20.03.01(i). Ruling #3453557.

## Races:

Race 1: #6 Nice Buns was scratched lame by the Official Veterinarian after warming up and was placed on the Short-Term Vet's List.

Reviewed the break of #8 Wednesdays Child after the start.

Race 2: **Inquiry:** #6 Fastlane Jane (D.Maclellan), finished 3<sup>rd</sup>, made a break going to the three-quarter pole and did not violate any of the AGCO breaking rules.

Race 3: Reviewed the break of #6 Century Liberty after the start and #7 Kaptain Khloe before the three-quarter pole.

#6 Century Liberty finished with broken equipment. (hopple)

#1 Rollthebet was placed on the Long-Term Vet's List (lame) post race by the Official Veterinarian.

Race 4: #2 Kosi Bay Kiwi must qualify for performance. The horse was distanced.

Race 5: Recall: #1 Prescelto made a break and caused interference to the trailer #9 Ladyterra.

Race 6: **Inquiry:** #4 Hes Express (J.Hunt) 2<sup>nd</sup> placed 8<sup>th</sup>, was third on the rail going to the three quarters, as the pace was slowing on the front, #4 Hes Express came out and caused the #1 Silver Majesty, 8<sup>th</sup> placed 7<sup>th</sup>, (S.Fillion) to change course as #4 came out of the hole before there was room.
