## Report on day's events:

**Office:** Horseperson Terry Gallant was ordered to return purse money (\$18161.77), trainer fees (\$2313.77), and the monetary penalty (\$2000.00) before December 8<sup>th</sup>, 2025, from the dismissed HRAP appeal #05044 2025. Failure to do so will result in a full suspension. AGCO Rules 1.09, 5.11, 6.01(a)(c), 6.15, 18.08.01. Ruling #3463104.

## Races:

Race 1: #9 Dali Dalite must qualify for performance. The horse was distanced.

Race 2: #7 Fastlane Jane was scratched by the Official Veterinarian after the post parade and placed on the Short-Term Vet List (lame). Refund: \$1995.00.

Race 3: #6 Del Diggity pulled up and did not finish and placed on the Judges' List for performance. The horse was also placed on the Long-Term Vet's List (lame) by the Official Veterinarian.

Race 4: #6 Wicked Craving left the track by going into the safety lane before the threequarter pole and was placed on the Judges' List for performance and must qualify. The horse was placed on the Short-Term Vet's List (sick) by the Official Veterinarian. Reviewed the break of #8 Streakassedy before the start.

Race 6: #6 Sweet Sister was scratched lame after warming up and placed on the Short-Term Vet's List.

Driver Mike Whelan will attend the Judges' office to review his urging with his whip in the stretch while driving #5 Mclatte.

Race 8: #1 Mymomsanace pulled up at the head of the stretch and did not finish. The horse must qualify for performance and as per AGCO Rule 12.06 was placed on the Short-Term Vet's List as the horse choked.
