Report on day's events:

Office: Races were delayed 20 minutes as the track was soft in the stretch, and the temperature needed to lower to freeze dry the racing surface.

Races:

Race 1: #6 Royel Sport, 5th, was charted with interference from the break of #2 Blackmagiccheddar, 6th, after the three-quarter pole. No placings needed.

Race 2: **Inquiry:** #3 Wicked Ending (T.Ratchford) was inside two pylons around the last turn and was lapped on at the finish by #6 Allstar Bruiser (P.Mackenzie). #3 Wicked Ending finished 3rd and was placed 4th, #6 Allstar Bruiser finished 4th and was placed 3rd. The back tower video shows that #3 Wicked Ending was not forced into the pylons by #2 Bet I Will (A.Sorrie). #3 Wicked Ending also went inside the pylon that goes into the passing lane but did not gain an advantage by doing so. No penalty to driver Ratchford, as the horse was visibly bearing in.
