- 1. The #4 BIG ART FALLON (Pascal Berube) finished distanced and must qualify for performance (trainer notified). Clear.
- 2. Inquiry on #5 BABYLOU (Marie-Claude Auger), who finished fourth; #5 broke in the stretch, did not violate any of the breaking rules and did not cause interference to another horse; no change to the order of finish.

The #1 HARDOO PARKING (Darcy Clancy) broke before the 3/4 mile pole and while off stride did cause interference to #6 MUKTUK ANNIE (Robert Shepherd); no placing required as #1 finished fifth (last). Clear.

- 3. The #4 SPORT A LUCKY STAR (Marie-Claude Auger) must qualify for time (2082) (trainer notified). Clear.
- 4. Corrected race fractions: 28<sup>2</sup> 59<sup>1</sup> 129<sup>3</sup> 200<sup>4</sup>. Clear.

- 6. Late Judges scratch (weather) of PILOT HEIR (Luc Loyer trainer); refund: \$257. The #6 ROSE RUN WHY NOT (Marie-Claude Auger) suffered broken equipment (rear brace bandage) after the ¾ mile pole and finished with broken equipment. Clear.
- 7. Recall due to broken equipment (hopple hanger) on #1 PERSISTANT BOY (William Roy) followed by a subsequent recall due to broken equipment (flat tire) on #5 SIDDHARTHA (Marie-Claude Auger). Clear.

Inquiry concerning #9 MONTYGONEMARBLE (Mike Healey) leaving the course after the ¼ mile pole and driver's objection concerning possible interference to #9 by #2 PERFECT ROLO (Sylvain Lacaille) before the ¼ mile pole; after reviewing the race video and speaking with both drivers (Mr. Healey stated he had been crowded by #2 forcing him into the pylons; Mr. Lacaille stated #9 had driven up on his several times) it was determined that #2 did cause interference to #9 before the ¼ mile pole; after the ¼ mile pole #9 did leave the course, gain ground and reenter the race course in a more advantageous position; #9 finished fifth placed eighth per AGCO rule 18.08.02.01(c) (leaving the course, gaining an unfair advantage and improving position).
