Race 2 – All Clear

Race 3 – Inquiry – Reviewed racing at the top of the stretch between #5 Masterwork (Samuel Fillion) and #6 No One (Austin Sorrie). The pan video shows #5 is racing first-over, #6 goes wide on the turn while sitting in the two-hole and comes out to #5. The Panel ruled #5 did not cause interference to #6, no violations.
