Races:

Race 2: Clear.

Race 3: Reviewed the breaks of #3 Lmc Little Chips, finished 6th, before the start and #5 Lockdown Romeo, finished 8th, before the quarter pole.

The judges used the lower pan to determine the final order of finish due to e-photo malfunction.
