### RACES

#### Race 1

Reviewed deep stretch racing action where **#9 Erinwood Big Mack (Tra. Henry) (2<sup>nd</sup>)** drifts out right before the wire and appears to make wheel to wheel contact with **#2 Rbstenacious (T. Cullen) (1<sup>st</sup>)**. No inquiry needed as **#2 Rbstenacious** won the race.

#### Race 2

**#4 Highlandbeachlover (D. Thiessen) (1<sup>st</sup>)** was examined post-race by the official vet and placed on the short-term vet's list (lame).

#### Race 3

Reviewed break made by **#10 Mandestiny (T. Cullen)** shortly after the start, no violations of the breaking rule.

Race 4

**Judges Inquiry** looking at the start of the race in regard to **#7 One More Bet (J. Jamieson)**. The horse made a break before the word "go" but was inside the fair start pole...no pari-mutuel refund needed.

Race 5

Reviewed break just after the start by **#1 Laneside Incontrol (D. McNair) (10<sup>th</sup>)**, no violations of the breaking rule.

Race 9 – No Show Wagering

Reviewed racing action just after the half when **#6 Taurasi (D. McNair) (6<sup>th</sup>)** made a break. Spoke with driver of **#3 Pacino Hanover (T. Cullen) (6<sup>th</sup>)** who said the break really didn't affect him much. The Judges deemed **#2 Brue Hanover (J. Jamieson) (4<sup>th</sup>)** did suffer interference caused by **#6 Taurasi** while off stride but finished ahead of that rival...no placings needed.

Race 10

**#6 Southwind Sambucca** needs a Coggins before it's next start.

Race 11

**Judges Inquiry** reviewing the stretch run regarding **#6 Longshot Panic (J. Jamieson) (4<sup>th</sup>)**. The horse went inside two consecutive pylons and was lapped by **#2 Blue Bar (T. Cullen) (5<sup>th</sup>)**. As a result, #6 finished 4<sup>th</sup> and was placed 5<sup>th</sup> for a pylons violation...#2 finished 5<sup>th</sup> and was placed 4<sup>th</sup>.
