Ruling #3525456 generated – Trainer Carmen Auciello did fail to ensure the driver availability for “Remember The Beach” in race #2. Mr. Auciello has been issued a \$100.00 monetary penalty. AGCO rule #17.19

Ruling #3525463 generated – Driver Jonathan Drury did fail to drive “Hes Swift”, without being excused by the Judges in race #8. Mr. Drury has been issued a \$100.00 monetary penalty. AGCO rule #6.02(a)

**Race 2 – “Inquiry”** in the stretch - #7 “Tellit Russ Tellit” (Cullen 2<sup>nd</sup>) does go up the side of #2 “Bettor On Ice” (McNair 3<sup>rd</sup>), #7 hits 2 pylons but does not go inside any... both horses are wheel to wheel for a little, neither driver stop driving, no violations.
