R4 – #6 Dream Valley (G. Rooney, 6<sup>th</sup>) made an extended break after the ½, no placing required.

R5 - # Royal Flush Magic (J. Ryan, 7<sup>th</sup>) made an extended break on the first turn, no placing required.

R6 - #6 Sportsense (A. Sorrie, 6<sup>th</sup>) was out distanced in the race and must qualify for performance. Trainer Cameron McQueen was notified.

R9 – Reviewed racing in the final turn where #3 Ladies From Hell (G. Rooney, 2<sup>nd</sup>) hits three consecutive pylons but was not inside any. No violation.
