**RULING # 3546632:** From Monday January 26<sup>th</sup>. Trainer C. McQueen was assessed a \$100 monetary penalty. Mr. McQueen failed to remove his horse from the Lasix stall when instructed to do so by a race official. AGCO Rules 5.11 and 32.01 (a) refer.
