AGCO Judges ruled Driver **Tyler Jones** violated **rule 6.02(a)** (failing to drive when programmed) and wasn't excused. Mr. Jones has been assessed a \$100 monetary penalty. Ruling **#3551505**.

RACES

Race 1 - Reviewed racing action at the stop of the stretch. **#4 Winchester Phoenix (T. Borth) (7th)** made a break. Borth "I was full of pace and Brett's horse was stopping fast, I ended up catching his wheel". As a result, Judges chartered **#4** with an "IX" where the incident occurred. No placings needed.

#6 Bettor B Going (J. MacDonald) (1st) finished with broken equipment (right front shoe).

Race 2 - Judges Inquiry looking into racing action at the top of the stretch. **#2 Devils Arch (J.R. Plante) (2nd)** went inside two pylons. Plante "I was just following Travis". #2 was lapped at the wire by **#5 Veracruz (B. McClure) (3rd)**. #2 finished 2nd and was placed 3rd, #5 finished 3rd and was placed 2nd. The reason for the placing is a pylon violation.
