Notification of Positive Test issued for a class IV substance (glycopyrrolate) to trainer Robert Kyle Fellows for the horse Bella Cavalla, who raced at Mohawk Park on February 1st, 2026, in Race 8. Certificate #53 26032 327. This is Mr. Fellows second offence in a three-year period and will therefore be referred to AGCO Head Office. Mr. Fellows was notified that any horses leaving his barn will require a trainer transfer before entering to race. He will be in to pick up his disclosure on Saturday.
