Reviewed the breaks of #3 Crypto Hanover before the quarter and #4 Fateful in the stretch.

#4 Fateful must qualify for breaks.

Race 4: **Inquiry:** #3 Summer Dancer (D.Kelly) came across in the stretch and caused interference to #2 Chef (B.McClure) making the horse go briefly off stride. As a result, #3 Summer Dancer finished 3rd and was placed 6th.
