Race Officials Dorion, Portuondo and Fines issued a 10-day driving suspension from February 10<sup>th</sup> to February 19<sup>th</sup>, 2026, inclusive and a \$1000 monetary penalty to driver Doug McNair for violation of AGCO Rules 6.01, and 6.20(b), misconduct prejudicial to the best interest of racing. The violation occurred while driving Tricky Mcwicky after Race 8 on January 10<sup>th</sup>, 2026. Ruling #3558637.

Ondrej Gois was excused from one drive. (Race 4)

Race 1: **Inquiry:** #6 Tropical Cyclone made a break before the start caused by a broken hopple. Refund: \$40 451.

Race 2: #7 Code Switch must qualify for performance. The horse was distanced.
