Race 1 – Reviewed breaks on #1 Divine Love (JR Plante, 5th) and #3 Romancing Ritz (B.McClure, 8th). #1 broke after the start. No violations. #3 broke before the start and was well inside the fair start pole. #3 must also qualify for breaks.

Also, reviewed stretch drive on #4 Acrobatic (T. Ratchford, 2nd) who was in the lead coming into the stretch and drifted out allowing #8 The Hitman Heart (J. Drury, 1st) up the inside. #4 is visibly bearing out and driver Ratchford tries to keep the horse down. No further action required.
